

## PUBLIC NOTICE UNDERGRADUATE TEACHING AND LEARNING FACILITY

## March 1, 2024

University of California, Riverside (UCR) has published Addendum No. 2 to the 2021 Long Range Development Plan (LRDP) Environmental Impact Report (EIR).

**Project Location:** The Undergraduate Teaching and Learning Facility (UTLF) site is located at the eastern terminus of the University Avenue and Canyon Crest Drive intersection, within the UCR East Campus. The land use designation for the site in the 2021 LRDP is University Avenue Gateway.

**Project Description:** The proposed UTLF Project would entail development of approximately 100,700 gross square feet of new academic space. The space program is focused on undergraduate education and incorporates the following types of spaces, which strategically address some of the campus' most pressing instruction and instructional support space needs:

- General assignment classrooms
- Specialized teaching spaces such as labs and studios supporting the arts, engineering, and physical and natural sciences
- Instructional support spaces

UC Board of Regents Meeting: On March 19-21, 2024, the UC Board of Regents will meet to, among other items, consider approval of the UTLF Project following review of the Addendum No. 2 to the 2021 LRDP EIR. California Environmental Quality Act (CEQA) and project design actions will consist of: 1) adoption of the CEQA Findings for the UTLF Project having considered both the 2021 LRDP EIR and Addendum No. 2 to the 2021 LRDP EIR for the UTLF Project; 2) make a condition of approval implementation of the applicable mitigation measures and continuing best practices identified in Addendum No. 2 to the 2021 LRDP EIR as identified in the Mitigation Monitoring and Reporting Program adopted in connection with the 2021 LRDP EIR; and 3) approval of the design of the UTLF Project.
